Paper size: A4

Times New Roman 12 for title, author and summary of contents

Times New Roman 10 for footnotes

Page Margins: 3

Line spacing: 1,15

- The SUMMARY should be divided into numbered paraghaphs.
- In the text, the paraghaphs should be numbered in bold, followed by the title.
- Foreign words in *italics*, unless they are not in common use in the chosen language.
- To texts citations, use “ ”.

All contributions should include an abstract (no more than 10 lines) in English and five key-words in English.
